

## **LIMITED DRIVING PRIVILEGES:** **LICENSE RESTRICTION**

Limited Driving Privileges are granted at the discretion of the Court which means Limited Driving Privileges are not always granted by the Court.

If your license has been **restricted** by the Court, you may petition the Court to request Limited Driving Privileges.

The Court may grant Limited Driving Privileges if there is reasonable cause to believe that the suspension will **seriously** affect your ability to continue in:

1. Employment or
2. School (including regularly scheduled school activities);

You will need to explain to the Judge/Magistrate why the license suspension will **seriously** affect your ability to continue in employment or educational training (school) during the period of your restriction before the Court will consider granting you Limited Driving Privileges. Generally, this means that if you have another means to get to school (the bus) or work the Court will not grant your request for Limited Driving Privileges.

If the Court finds it appropriate to grant you Limited Driving Privileges during the period of your license restriction at a **minimum** you will be required to comply with the following conditions and your failure to do so **will** result in the Court immediately revoking your Limited Driving Privileges Permit:

1. When traveling to and from the places listed in your Limited Driving Privileges Permit, you **must** take a direct route and are not permitted to stop for any purpose (store, etc.), **except** that you are permitted to stop for gas en route to and from the places listed in your Limited Driving Privileges Permit;
2. No passengers are permitted in the car while you are driving other than a parent unless otherwise specified by the Court;
3. You must strictly comply with **all** laws (traffic, criminal, curfew, etc.);
4. You are not permitted to use your cell phone for any purpose, including, texting while driving with a Limited Driving Privileges Permit; and
5. You must maintain automobile liability insurance.

Your petition for Limited Driving Privileges **must** be accompanied by the following written documentation before a Limited Driving Privileges Permit will be granted by the Court:

1. A current copy of your proof of insurance;
2. **For school privileges**, a letter from the school on school letterhead stating that you are a student and what days and hours school is in session;
3. **For school activities**, a schedule indicating what days and times you are required to be at the school activity;

4. **For employment**, a letter from your employer on letterhead stating that you are an employee and what days and hours you will be working as well as the manager/supervisor's name and contact phone number. This letter should also state the hours of operation for the employer.

**\*\* NOTE: O.R.C. § 4510.31(C)(1) requires that the Court specify the purposes, dates, times and places to and from which the Juvenile will be driving.** Absent this specific information, the Court will not grant your request for Limited Driving Privileges for employment purposes.

Your failure to provide any of the items listed will result in the Court denying your request for Limited Driving Privileges.

It is important that all documents you submit clearly indicate your name and case number. Your failure to provide this information may delay the processing of your request.
