**MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT**

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on April 16, 2008, the County Executive submitted to the Council President and Clerk of Council two letters nominating Ms. Cindy Fink and Mr. Keith D. Shy to the Summit County Green Policy Task Force; on April 17, 2008, the County Executive submitted to the Council President and Clerk of Council three letters nominating Ms. Paula P. Davis, Mr. Daniel V. Steen, and Mr. Carmine Torio to the Summit County Green Policy Task Force; and on April 21, 2008, the County Executive submitted to the Council President and Clerk of Council two letters nominating Mr. William Skowronski and Ms. Lisa Bostwick to the Summit County Green Policy Task Force; and

Whereas, upon receipt of an appointment nominating letter, Section 121.06 of the Codified Ordinances of the County of Summit requires the Council President to present a Motion of Council to the County Council for its consideration and action;

NOW, THEREFORE, IT IS MOVED, BY THE COUNCIL OF THE COUNTY OF SUMMIT, that:


