A Resolution approving the classification, classification specification and salary schedule for the non-bargaining, classified position of Jail Population Control Administrator #29221, for the Summit County Sheriff and the Human Resource Commission, and declaring an emergency.

WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10) of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the Codified Ordinances to establish classifications, classification specifications and pay/salary schedules for all County employees; and

WHEREAS, the County Sheriff has requested pursuant to Section 169.11 that the classification, classification specification and salary schedule for the non-bargaining classified position of Jail Population Control Administrator #29221 be approved to provide control of the inmate population at the summit County Jail; and

WHEREAS, at its June 12, 2006 meeting, the Human Resource Commission approved the classification, classification specification and salary schedule for the aforementioned position, as stated in Order #06-06, attached hereto as Exhibit A and incorporated herein as if fully restated; and

WHEREAS, this Council has determined by reviewing all pertinent information that the approval of the new classification, classification specification and salary schedule for the non-bargaining, classified position of Jail Population Control Administrator #29221 is necessary and in the best interest of the County of Summit

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The following classification is approved:

JAIL POPULATION CONTROL ADMINISTRATOR #29221

New classification, classification specification

The classification specification for the aforementioned classification, which is attached hereto as Exhibit B and incorporated herein as if fully restated, is hereby approved. The aforementioned classification is assigned the salary schedule of Category 3, Grade 6 as indicated in Exhibit C, attached hereto and incorporated herein as if fully restated.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens and employees of the County of Summit, and for the further reason that it is necessary in order to approve a new classification, classification specification and salary schedule for the new non-bargaining classified position of Jail Population control Administrator.
