A Resolution approving the classification, classification specification and salary schedule for the non-bargaining, classified position of Service Contract Coordinator #29730, for the Summit County Prosecutor – Child Support Enforcement Agency, and the Human Resource Commission, and declaring an emergency.

WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10) of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the Codified Ordinances to establish classifications, classification specifications and pay/salary schedules for all County employees; and

WHEREAS, the County Prosecutor has requested pursuant to Section 169.11 that the classification, classification specification and salary schedule for the non-bargaining classified position of Service Contract Coordinator #29730 be approved to provide for employees to be placed in proper classification related to job duties in the Child Support Enforcement Agency; and

WHEREAS, at its June 12, 2006 meeting, the Human Resource Commission approved the classification, classification specification and salary schedule for the aforementioned position, as stated in Order #06-05, attached hereto as Exhibit A and incorporated herein as if fully restated; and

WHEREAS, this Council has determined by reviewing all pertinent information that the approval of the new classification, classification specification and salary schedule for the non-bargaining, classified position of Service Contract Coordinator #29730 is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1 The following classification is hereby approved:

SERVICE CONTRACT COORDINATOR #29730

New classification, classification specification

The classification specification for the aforementioned classification, which is attached hereto as Exhibit B and incorporated herein as if fully restated, is hereby approved. The aforementioned classification is assigned the salary schedule of Category 2, Grade 5 as indicated in Exhibit C, attached hereto and incorporated herein as if fully restated.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens and employees of the County of Summit and for the further reason that it is necessary in order to immediately approve a new classification, classification specification and salary schedule for the new non-bargaining classified position of Service Contract Coordinator.

SECTION 3

Provided the Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.


SECTION 4

It is found and determined that all formal actions of the Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of the Council, and that all deliberations of the Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
