An amended Resolution approving the classifications, classification specifications and salary schedules for the exempt unclassified positions of Direct Indictment Officer I, #50040 and Direct Indictment Officer II, #50041, for the Prosecutor, and declaring an emergency.

WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10) of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the Codified Ordinances to establish classifications, classification specifications and pay/salary schedules for all County employees; and

WHEREAS, the County Prosecutor requests that the classifications, classification specifications and salary schedules for the exempt unclassified positions of Direct Indictment Office I, #50040 and Direct Indictment Officer II, #50041 be approved by this Council to serve under the Prosecutor in her Direct Indictment Program; and

WHEREAS, approving the aforementioned positions and placing them under the Prosecutor rather than having such positions employed by outside agencies will allow better supervision and more efficient operation of the Direct Indictment Program; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to approve the classifications, classification specifications and salary schedules for the unclassified positions of Direct Indictment Office I, #50040 and Direct Indictment Officer II, #50041;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The following classifications are approved, designated as exempt unclassified and are assigned the following salary schedules and pay codes:

SECTION 4


