A Resolution appropriating funds in the amount of \$1,467,500.00 from State of Ohio Department of Youth Services State Fiscal Year 2009 Delinquent Care and Custody "RECLAIM" Grant, with no local cash match, for the period August 1, 2008 through December 31, 2008, for the Juvenile Court, and declaring an emergency.

WHEREAS, Resolution No. 2008-249 authorized the County Executive to accept the award of the State Fiscal Year 2009 RECLAIM Grant for the period July 1, 2008 through June 30, 2009, and appropriated \$346,000.00 for the initial months of the grant; and,

WHEREAS, it is necessary to appropriate RECLAIM grant funds for the balance of the 2008 calendar year in the amount of \$1,467,500.00 for the Summit County Juvenile Court; and,

WHEREAS, this Council has determined by reviewing all pertinent information that the appropriation of the aforementioned grant funds is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The State Fiscal Year 2009 Delinquent Care and Custody "RECLAIM" Grant Funds are hereby appropriated as follows:
