7 **A Resolution increasing appropriations in the General Fund and other operating funds to**
8 **meet separation costs related to the County of Summit Voluntary Separation Plan, for the**
9 **Executive, and declaring an emergency.**

11 WHEREAS, on April 13, 2009, County Council adopted Resolution No. 2009-112,
12 whereby the County of Summit Voluntary Separation Plan ("the Plan") was authorized and
13 approved, the County Executive was authorized to administer the Plan and the Plan was made
14 available to all County appointing authorities, offices, agencies, boards and commissions
15 ("Office/Offices"); and

16
17 WHEREAS, on June 29, 2009, County Council adopted Resolution No. 2009-272,
18 transferring mandatory salary savings in the General Fund to cover the cost of employee payouts;
19 and

21 WHEREAS, on September 28, 2009, County Council adopted Resolution No. 2009-360,
22 whereby the Plan was re-opened, authorized and approved, the County Executive was authorized
23 to administer the Plan and the Plan was made available to all County Offices; and

25 WHEREAS, additional appropriations are required to cover the cost of employee payouts
26 in excess of the 2009 salary savings previously approved in the General Fund and to cover the
27 cost of employee payouts in other operating funds of the County; and

29 WHEREAS, this Council has determined by reviewing all pertinent information that the
30 appropriations are necessary and in the best interest of the County of Summit;
