7 **A Resolution appropriating funds in the amount of \$249,181.76 in the Chrysler Rapid**  
8 **Response Fund, for the Executive's Department of Community and Economic**  
9 **Development, and declaring an emergency.**

11 WHEREAS, federal funds from the American Recovery and Reinvestment Act of 2009  
12 ("ARRA") are available through the State of Ohio's Workforce Investment Act ("WIA") Rapid  
13 Response Grant and the National Emergency Grant ("NEG") for the purpose of providing  
14 employment and skills counseling to displaced workers affected by layoffs at the Chrysler's  
15 Twinsburg Stamping Plant and the Plant's eventual closure and assist such workers in locating  
16 and securing new employment and/or training opportunities; and

17  
18 WHEREAS, the County of Summit, Ohio, the County of Summit Department of Job and  
19 Family Services ("SCDJFS") and the County of Summit Department of Community and  
20 Economic Development ("SCDCED") wish to enter into a Memorandum of Understanding  
21 ("MOU") pursuant to which SCDCED will provide employment and skills counseling and  
22 training opportunities to displaced workers, which will be funded through the WIA Rapid  
23 Response Grant and the NEG (the "Project") with a term of May 1, 2010 through June 30, 2011;

26 WHEREAS, appropriations are required to provide for the costs associated to operate the  
27 Project including, but not limited to, employee wages, benefits and additional expenses as set  
28 forth in Schedule B to the MOU and Resolution No. 2010-189 amends the Report on Staffing to  
29 allow for the temporary positions until June 30, 2011; and

31 WHEREAS, this Council has determined by reviewing all pertinent information that the  
32 aforementioned appropriations are necessary and in the best interest of the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
